GENERAL COURTESIES

- Contact the provincial or municipal office well in advance of the actual production date. Filming, locations, vehicle and transportation permits, permissions and expectations may vary from one jurisdiction to another in Manitoba.
- Follow the provisions of all motion picture production filming location permits issued by the Province, a municipality, or other local government. Extensions and requests for changes to permits must be made and be granted in writing.
- The Manitoba Highway Traffic Act is in effect at all times.
- Removing or cutting signs or plants from any public or private location without permission is prohibited.
- Reduce, reuse and recycle.
- Notify the public in writing, five business days in advance, whenever production activities may directly affect or disrupt daily lives. Include the following information:
 - The working title of the project;
 - Name of the company;
 - Someone to contact with any concerns;
 - Date and time of disruption; and,
 - A brief, clear description of the activity.

PROFESSIONALISM

- No trespassing on private property. Remain within the boundaries of the permitted locations and do not use items that have not been approved for use by the production.
- Maintain all properties in original or better condition.
- All equipment in public spaces should be stored neatly and cables channeled safely.
- Alcohol and cannabis consumption are prohibited.
- Tobacco smoking, meal service and eating are allowed in designated areas only. Dispose of cigarette butts in appropriate containers.
- Keep noise and talking to a minimum at all times and refrain from using lewd or improper language.
- Wear a production pass, as required.
- No guests or pets are allowed on the location, without advance permission.
- Offensive or objectionable materials on clothing or vehicles will not be tolerated.
- Comply with Manitoba's Workplace Safety and Health Regulations, The Manitoba Media Production Industry Safety and Health Guidelines, and maintain a respectful workplace at all times.
